



FIRST COMMERCE CREDIT UNION ACCELERATE SHARE YOUR STORY PROMOTION OFFICIAL RULES

January 17, 2022

NO PURCHASE, ACCOUNT OPENING, ACCOUNT TRANSACTION, OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

ELIGIBILITY: Open only to legal residents of the United States who are 18 years old or older as of January 17, 2022, with a valid driver's license or government issued ID. Entrants must also live or work in a county located within First Commerce Credit Union's Field of Membership. Employees of First Commerce Credit Union ("Credit Union") and their and their immediate family members (defined as parent, spouse, child, sibling, or grandparent and each of their respective spouses) and/or those living in the same household of each are not eligible to enter.

TIMING: Promotion begins at 9 a.m. Eastern Standard Time ("EST") on January 17, 2022, and ends at 5 p.m. EST on Friday, February 25, 2022.

HOW TO ENTER: To enter the Accelerate Share Your Story drawing, visit the First Commerce Credit Union web site at Checking.FirstCommerceCU.org/Accelerate, or any of the Credit Union's 15 locations and submit a written story in 50 words or less about how the Accelerate Account has helped you to enhance your financial well-being. You may also enter by printing your name, address, city, state, zip code, area code and telephone number and e-mail address on a 3" x. 5" postcard, and (1) mailing the postcard to: First Commerce Credit Union, ATTN: Accelerate Stories, P.O. Box 6416, Tallahassee, FL 32314, or (2) dropping the postcard off at any of the Credit Union's 15 locations. Limit one entry per person. Mail-in entries must be postmarked by Wednesday, February 23, 2022, to be eligible for the drawing. All entries and requests become Credit Union's property and will not be returned or acknowledged. Credit Union is not responsible for lost, late, damaged, misdirected or postage due mail. Credit Union may grant the right to add additional entries deemed necessary or appropriate under the rules.

PRIZE: One (1) prize will be awarded: \$50 gift card/certificate to a local business of your choice operating legally within First Commerce Credit Union's Field of Membership (See counties within the Field of Membership at [FirstCommerceCU.org/About-Us/Become-a-Member/](https://www.FirstCommerceCU.org/About-Us/Become-a-Member/)). Odds of winning depend on the total number of eligible entries received. No substitutions are permitted except if prize is unavailable, in which case a prize of equal or



greater value will be awarded. Prize is not redeemable for cash. Prize is non-assignable or transferable except to a surviving parent/legal guardian or an estate. Winner is responsible for all applicable federal, state, local taxes. Any other incidental expenses or destination charges on prize not specified herein are the sole responsibility of winner. Gift card/certificate subject to the terms and conditions of the local business issuing the card/certificate.

RANDOM DRAWING: On Tuesday, March 1, 2022, at 9:00 a.m. (EST) a winner will be selected by random drawing from all eligible entries received. Drawing conducted by a Credit Union employee at First Commerce headquarters in Tallahassee. Credit Union's decisions on all matters related to this promotion shall be final and binding. A participant selected as a potential winner must comply with all terms and conditions set forth in these Official Rules, and winning is contingent upon fulfilling all such requirements.

NOTIFICATION: Winner will be notified in writing via email and, at the Credit Union's discretion, will be required to complete and return an Affidavit of Eligibility and Liability and, except as prohibited by law, a Publicity Release within 1 day of date specified on notification, or an alternate winner will be selected. Prizes awarded within 5 days after receipt of affidavit or prize notification. If an affidavit or prize notification is returned as undeliverable, it will result in disqualification, and the prize will be awarded to an alternate winner selected by random drawing.
